### **SIGNIFICANT EVENT**

Today, TELEFÓNICA, S.A., through its wholly- owned subsidiary TELEFÓNICA EMISIONES, S.A.U., under its Guaranteed Euro Medium Term Note Programme (EMTN Programme) filed with the Financial Services Authority (FSA) in London on June 20<sup>th</sup>, 2011, has launched an issue of Notes guaranteed by TELEFÓNICA, S.A. in the Euro market amounting 1,500 million euro.

These Notes, due on February 21<sup>st</sup>, 2018, pay an annual coupon of 4.797% and have a reoffer price of 100%. Settlement and closing date is scheduled for execution on February 21<sup>st</sup>, 2012.
