SIGNIFICANT EVENT

Today, TELEFÓNICA, S.A., through its wholly- owned subsidiary TELEFÓNICA EMISIONES, S.A.U., under its Guaranteed Euro Medium Term Note Programme (EMTN Programme) filed with the Financial Services Authority (FSA) in London on June 12th, 2012, has launched an issue of Notes guaranteed by TELEFÓNICA, S.A. in the Euro market amounting 1,200 million euro.

These Notes, due on January 20th, 2020, pay an annual coupon of 4.71% and have a reoffer price of 100%. Settlement and closing date is scheduled for execution on October 19th, 2012.
