The advisory councils are a support mechanism for the governing and management bodies of commercial companies, whose objective is, among others, to accelerate growth and improve the competitiveness of the business sector, to facilitate the presentation of trends, help shape value propositions, contribute innovative ideas, enrich the strategic debate, contribute to the continuous search for reputational improvements and, in any case, contribute to the generation of debates that include the sustainable and profitable transformation of commercial companies.

Telefónica Tech was born in November 2019 as one of the <u>five pillars of the Telefónica Group's strategic plan</u> to drive the company's transformation. Currently comprising two divisions (one for the Cloud and Cyber Security businesses and the other focused on IoT, Big Data, Artificial Intelligence and Blockchain), Telefónica Tech closed the first nine months of the year with a 25.5% increase in revenues and expects to continue with double-digit growth thanks to the opportunity represented by the Telefónica Group's more than 5.5 million B2B customers.
