LEGAL BASES APPLICABLE TO THE PROMOTION

1. FIRST. - Organisation.

TELEFÓNICA, S.A., CIF. A-28015865, registered office in Madrid 28013, C/Gran Vía 28 (hereinafter, TELEFÓNICA), announces the following Promotional Prize Draw (hereinafter, the "Prize Draw").

2. SECOND.- Territorial scope.

The territorial scope of this prize draw is worldwide.

3. THREE. - Promotion Validity Period

The period established for this prize draw will run from 00:01 hours (Spanish mainland time) on 16th October 2023 until 23:59 hours (Spanish mainland time) on 29th October 2023 (hereinafter referred to as the "Prize Draw Period").
