## Telefónica files to voluntarily deregister and suspend SEC reporting obligations

Telefónica, S.A. (“Telefónica”) announces that, following the announcement of its intention to delist its American Depository Shares and certain series of debt securities from the New York Stock Exchange, as stated in the press release of December 17, 2025, Telefónica and two wholly-owned subsidiaries of Telefónica —Telefónica Emisiones, S.A.U. and Telefónica Europe, B.V.—, are voluntarily filing today Forms 15F with the Securities and Exchange Commission (“SEC”) to suspend immediately their reporting obligations under the U.S. Securities Exchange Act of 1934, as amended. The deregistration and termination of such reporting obligations is expected to become effective 90 days after the filing of the Forms 15F, unless objected to by the SEC. Telefónica will continue to prepare its consolidated financial statements in accordance with International Financial Reporting Standards (IFRS).
