This supplement (the "**Supplement**") to the base prospectus dated 12 April 2019, as supplemented on 17 May 2019 (the "**Base Prospectus**") constitutes a supplementary prospectus for the purposes of Article 16 of Directive 2003/71/EC and is prepared in connection with the programme for the issuance of debt instruments (the "**Programme**") established by Telefónica Emisiones, S.A.U. (the "**Issuer**"). Terms defined in the Base Prospectus have the same meaning when used in this Supplement.

This Supplement has been approved by the Central Bank of Ireland (the "**CBI**") in its capacity as competent authority under Directive 2003/71/EC, as amended (the "Prospectus Directive"). The CBI only approves this Supplement as meeting the requirements imposed under Irish and European law pursuant to the Prospectus Directive.

The purpose of this Supplement is to incorporate by reference into the Base Prospectus Telefónica's Half-Yearly Financial Report covering the six-months period ended 30 June 2019.

This Supplement is supplemental to, and should be read in conjunction with the Base Prospectus, and any other supplements to the Base Prospectus issued by the Issuer.
